WORKER DIES WHEN MOWER FLIPS INTO POND

A 74-year-old Bushkill Township employee died in a lawn mower mishap. Mr. Louis Nagy was operating a riding mower when it happened at Albert Ponds Reserve along Albert Road, Coroner Zachary Lysek said. It is believed Nagy was cutting grass along the bank of the pond when the mower tipped over while he was seated on it, pinning him beneath the mower in the pond, Lysek said.

Consider the "Identifiable Victim Effect" in your Safety Presentations.

The identifiable victim effect refers to individuals' tendency to offer greater help to specific, identifiable victims than to anonymous statistical victims. This is why organizations that fight childhood hunger, for example, often focus on a single child to solicit more donations. In a safety context, sharing the personal narrative of someone who experienced a major injury may be more impactful - AND - elicit greater compliance.

Member Recognition

At our September meeting our Volunteer Leaders were presented with certificates for their work over the past year and for their new roles for this 24-25 ASSP Year.

We also presented our 23-24 Chapter Safety Professional of the Year (SPY) award to Bruce Higdon, CSP. Bruce is one of our chapter's original charter members.
